## APPLICATION RECOMMENDATIONS

For continually optimized pH and growing conditions, apply 250 kg/ha (220 pounds per acre) at least twice per growing season or as needed. Soil test recommendations should be used to determine liming needs.

To adjust pH, apply 500 kg/ha (435 pounds per acre). In most soils this will raise the soil pH up to one full point. Retest and if needed, reapply at the pH adjustment rate.

To be used only where there is a recognised need. Do not exceed the application rate.
