DIRECTIONS FOR USE Golf, Lawns, and Sports Turf

Apply 13 to 16 L/ha in 800 L of water (4 to 5 ounces per 1 000 ft² in 2 gallons) at 30 day intervals or as needed. After an initial 16 L (5 ounce) application, difficult to manage areas will respond best by applying 6 to 8 L/ha in 800 L of water (2 to 2.5 ounces per 1 000 ft² in 2 gallons) at 15 day intervals or as needed.

For increased surface firmness, apply 20 to 25 L/ha in 800 L of water (6 to 8 ounces per 1 000 ft² in 2 gallons) at 30 day intervals or as needed.

Irrigate with sufficient water to deliver **OARS PS** to the soil profile - 3 mm (1/8 inch) or more recommended.

DO NOT combine **OARS PS** in the spray tank with pesticides or fertilizers unless prior use has shown the combination physically compatible, effective and non-injurious under local conditions.

DOSIERUNG

Golf-, Sport- und Landschaftsrasenflächen

Verwenden Sie 13 bis 16 Liter pro Hektar mit 800 Liter von Wasser in Intervallen von 30 Tagen. Nach einer erstmaligen Anwendung von 16 Liter reagieren schwierig zu bearbeitende Bereiche am besten auf eine Anwendung von 6 bis 8 Litern pro Hektar in Intervallen von 15 Tagen.

Für eine verbesserte Bodenfestigkeit verwenden Sie 20 bis 25 Liter pro Hektar mit 800 Litern von Wasser in Intervallen von 30 Tagen.

Ausreichend Wasser verwenden, um OARS PS in das Bodenprofil einzuregnen – empfohlen werden 3 mm oder mehr.

DOSIS DE APLICACIÓN

Golf y césped deportivo

Aplicar de 13 a 16 litros por hectárea en 800 litros de agua a intervalos de 30 días. Tras una aplicación inicial de 16 litros, las áreas difíciles de gestionar responderán mejor aplicando de 6 a 8 litros por hectárea en 800 l. de agua a intervalos de 15 días.

Para una mayor firmeza de la superficie, aplicar de 20 a 25 litros por hectárea en 800 l. de agua a intervalos de 30 días.

Regar con agua suficiente para suministrar OARS PS al perfil de la tierra: se recomienda 3 mm o más.

TAUX D'ÉPANDAGE

Felouse de golf, sports et turf

Verser 13 à 16 litres par hectare dans 800 L d'eau à intervalles de 30 jours. Après une utilisation initiale de 16 litres, les zones difficiles à gérer répondront mieux en appliquant 6 à 8 litres par hectare dans 800 L d'eau à intervalles de 15 jours.

Pour la fermeté de surface augmentée, utiliser 20 à 25 litres par hectare dans 800 L d'eau à intervalles de 30 jours.

Iriguer avec suffisamment d'eau pour livrer OARS PS dans le sol - 3 mm ou plus recommandé.

Mentions de danger : Provoque une sévère irritation des yeux.

MODALITÀ DI APPLICAZIONE

Campi da golf, campi sportivi e prati

Utilizzare 13 a 16 litri per ettaro, in 800 litri d'acqua con un intervallo di 30 giorni. Dopo una prima applicazione di 16 litri, le aree difficili da gestire risponderanno meglio all'applicazione di 6 a 8 litri per ettaro in 800 litri d'acqua a intervalli di 15 giorni.

Per una maggiore compattezza della superficie, Utilizzare da 20 a 25 litri per ettaro, in 800 litri d'acqua con un intervallo di 30 giorni.

Irigare con sufficiente acqua per aggiungere OARS PS al profilo del suolo - si consigliano almeno 3 mm.

Indicazioni di pericolo : Provoca grave irritazione oculare.

Consigli di prudenza : Lavare accuratamente il viso, le mani e ogni parte esposta della pelle dopo l'uso. Indossare appositi guanti e indumenti di protezione, anche per occhi e viso. TOEPASSINGSHOEVEELHEDEN

Golf-, sport- en gazongras

Gebruik 13-16 liter per ha, in 800 liter water en met een interval van 30 dagen. Na een eerste toepassing van 16 liter reageren moeilijk te beheren oppervlakten het best door 6 tot 8 liter per hectare te gebruiken in 800 L water, met een interval van 15 dagen.

Voor een steviger oppervlak, gebruikt u 20-25 liter per ha, in 800 liter water en met een interval van 30 dagen.

Irigeren met voldoende water om OARS PS aan het bodemprofiel toe te voegen - 3 mm of meer is aanbevolen.

Gevenaandauidingen: Veroorzaakt ernstige oogirritatie.

Voorzorgsmaatregelen: Na het werken met dit product handen grondig wassen. Beschermende handschoenen/beschermende kleding/ogbescherming dragen. BIJ CONTACT MET DE OGEN: voorzichtig afdroegen met water gedurende een aantal minuten; contactlenzen verwijderen, indien mogelijk; blijven spoelen. Bij aanhoudende oogirritatie: een arts raadplegen.

TAXAS DE APLICAÇÃO

Campos de golfe, campos desportivos e relvados

Aplique entre 13 e 16 litros por hectare diluídos em 800 litros de água uma vez por mês (30 dias). Após uma aplicação inicial de 16 litros, as áreas de gestão difícil irão responder melhor se forem aplicados quinzenalmente 6 a 8 litros por hectare diluídos em 800 litros de água.

Para maior firmeza da superfície, aplique entre 20 e 25 litros por hectare diluídos em 800 litros de água uma vez por mês.

Regue o terreno com água suficiente para que o OARS PS atinja o perfil do solo - recomendamos 3 mm.

Advertências de perigo : Provoca irritação ocular grave.

Recomendações de prudência : Lavar as mãos cuidadosamente após manuseamento. Usar luvas de proteção, vestuário de proteção, proteção ocular.
